1 Be it enacted by the Senate and House of Representa-
2 tives of the United States of America in Congress assembled,
3 SECTION 1. SHORT TITLE.
4 This Act may be cited as the "Apostle Islands Na-
5 tional Park and Preserve Act".
6 SEC. 2. APOSTLE ISLANDS NATIONAL PARK AND PRE
7 SERVE.
8 (a) In General.—

1	(1) Redesignation.—Apostle Islands National
2	Lakeshore, established under Public Law 91–424
3	(16 U.S.C. 460w et seq.), shall be known and des-
4	ignated as "Apostle Islands National Park and Pre-
5	serve", comprised of—
6	(A) Apostle Islands National Park; and
7	(B) Apostle Islands National Preserve.
8	(2) Apostle islands national park.—
9	(A) Boundaries.—The boundaries of
10	Apostle Islands National Park are the bound-
11	aries of the area generally depicted as "Apostle
12	Islands National Park Proposed Boundary" on
13	the Map.
14	(B) ASHLAND HARBOR BREAKWATER
15	LIGHT.—Nothing in this Act creates a protec-
16	tive perimeter or buffer zone around the bound-
17	ary of the property labeled "Ashland Harbor
18	Breakwater Light" on the Map.
19	(3) Apostle islands national preserve.—
20	The boundaries of Apostle Islands National Preserve
21	are the boundaries of the area generally depicted as
22	"Apostle Islands National Preserve Proposed
23	Boundary" on the Map.
24	(b) Administration.—

1	(1) In General.—The Apostle Islands Na-
2	tional Park and Preserve shall be administered by
3	the Secretary as a single unit of the National Park
4	System in accordance with—
5	(A) this section;
6	(B) the laws generally applicable to units
7	of the National Park System, including—
8	(i) sections 100101(a), 100751(a),
9	100752, 100753, and 102101 of title 54,
10	United States Code; and
11	(ii) chapters 1003 and 3201 of title
12	54, United States Code; and
13	(C) except as provided in paragraph (2),
14	Public Law 91–424 (16 U.S.C. 460w et seq.).
15	(2) Hunting, fishing, and trapping.—
16	(A) Hunting and trapping.—
17	(i) Apostle islands national
18	PARK.—Except where permitted under a
19	treaty, statute, or executive order per-
20	taining to a Tribe, hunting and trapping
21	are prohibited within Apostle Islands Na-
22	tional Park.
23	(ii) Apostle islands national pre-
24	SERVE.—The Secretary shall administer

1	hunting and trapping within Apostle Is-
2	lands National Preserve—
3	(I) in the same manner that
4	hunting and trapping were adminis-
5	tered on the day before the date of
6	the enactment of this Act within the
7	portion of Apostle Islands National
8	Lakeshore that comprises Apostle Is-
9	lands National Preserve; and
10	(II) in accordance with section 5
11	of Public Law 91–424 (16 U.S.C.
12	460w-4) and other applicable laws.
13	(B) Fishing.—The Secretary shall admin-
14	ister fishing within the Apostle Islands National
15	Park and Preserve—
16	(i) in the same manner that fishing
17	was administered within the Apostle Is-
18	lands National Lakeshore on the day be-
19	fore the date of enactment of this Act; and
20	(ii) in accordance with section 5 of
21	Public Law 91–424 (16 U.S.C. 460w-4)
22	and other applicable laws.
23	(C) Private Land.—Nothing in this sec-
24	tion prohibits hunting, fishing, or trapping on

1	private land in accordance with applicable State
2	and Federal laws.
3	(c) References and Map.—
4	(1) References.—
5	(A) IN GENERAL.—Any reference in a law,
6	map, regulation, document, paper, or other
7	record of the United States to "Apostle Islands
8	National Lakeshore' shall be deemed to be a
9	reference to "Apostle Islands National Park
10	and Preserve''.
11	(B) Public Law 91–424.—Any reference in
12	Public Law 91–424 (16 U.S.C. 460w et seq.) to
13	the "lakeshore" shall be deemed to be a ref-
14	erence to "Apostle Islands National Park and
15	Preserve''.
16	(2) Map.—The Map shall be on file and avail-
17	able for public inspection in the appropriate offices
18	of the National Park Service.
19	(d) Interpretive Features.—The Secretary shall
20	include at the principal visitor centers of the Apostle Is-
21	lands National Park and Preserve the following interpre-
22	tive features:
23	(1) Signage that describes the history of the re-
24	gion, including information about the Ojibwe tribes,

1	early European settlers, fur trade, logging, stone
2	quarries, lighthouses and commercial fishing.
3	(2) A copy of this Act.
4	(e) Treaty and Reserved Rights.—Nothing in
5	this Act shall be construed as affecting any rights granted,
6	reserved, or established pursuant to treaty, statute, or ex-
7	ecutive order pertaining to any Tribe, including, but not
8	limited to, rights to hunt, trap, fish, and gather on lands
9	included within the boundary of Apostle Islands National
10	Park and Preserve or any other rights asserted by any
10 11	Park and Preserve or any other rights asserted by any Tribe.
